D. Programs developed within an organization

- 1. Advanced Coronary Bypass Surgery Program. I led the developed of this program at Stony Brook University Hospital in order to treat patients with advanced coronary artery disease and ischemic cardiomyopathy. Most of these patients have heart failure (Ischemic Heart Failure) and their treatment extends beyond the traditional CABG. The Advanced Coronary Program includes procedures such as Off-Pump Bypass Surgery, Coronary Endarterectomy, Trans-myocardial Laser Revascularization, Ventricular Aneurysm repair, Dor procedure, ventricular rupture operations and surgical revascularization supported with devices such as Intra-aortic balloon pump and Impella. Minimally Invasive Coronary Bypass Surgery, Robotic Assisted and Hybrid Revascularization procedures (CABG + Stents) are included in this program.
- 2. Cardiology-Cardiac Surgery High-Risk and Complex Case Conference. Stony Brook University Hospital (Co-Director). Robert Pyo, MD (Director of the Cardiac Catheterization Laboratory and Medical Director of Structural Disease) and I developed this conference to discuss prospectively in a multidisciplinary fashion complex and high-risk patients with heart disease. It is a working conference to assist with clinical decision making. Started Nov 13, 2019. Continued. List of patients, diagnosis, treatment selected, short term and follow up is kept and updated on a regular base.
- 3. **Hispanic Heart Center**. This program is still at an early stage of development at **Stony Brook**. The mission of this program is to treat Hispanic patients with heart disease beyond transcultural barriers in order to ameliorate health care disparities in the region. Other clinical areas in the Hospital (Cancer Center) as well as academic areas are partners in these programs in order to make this program institution wide beyond the clinical arena and also beyond cardiac disease.
- 4. Structural Heart Disease and Valve Surgery Conference and Clinic. Rush Copley Medical Center. Co-Director. Develop a multidisciplinary group for the presentation and discussion of clinical cases with complex structural heart disease.
- 5. Advanced Valve Surgery Program, Rush Copley Medical Center. Developed a successful cardiac valve program performing mitral valve repairs, double valve operations, septal myomectomies for IHSS, valve surgery for infective endocarditis, etc. These contributions in the context of a continuum of care with Rush University and the TAVR program.
- 6. **Off Pump Coronary Surgery Program, Rush Copley Medical Center.** Developed a successful Off Pump CABG program in an environment where no off-Pump CABG was done before.
- 7. **Off Pump Coronary Surgery, Italian Hospital of Buenos Aires.** Developed a successful Off Pump CABG program in an environment, which was reluctant to embrace it. Demonstrated better outcomes compared to on pump CABG.
- 8. Intraoperative neuro-protective strategy in cardiac surgery, Italian Hospital of Buenos Aires. Just like at Nashville VA, the routine utilization of intraoperative epi-aortic ultrasound to minimize the rate of perioperative strokes.
- 9. **Off-Pump Coronary Surgery, Nashville VA Medical Center.** This program was developed in 2008. Initially supported by Vanderbilt, the VA Cardiac Surgery Team acquired autonomy in the performance of these procedures very soon. Up to date, The VA has performed more than 220

off-pump bypass operations including triple vessel diseases and reoperations. Our VA Program is now one of the top 5 programs in the VA System in Off-Pump Coronary Surgery volume. The clinical outcomes have been excellent and almost 100% of all coronary operations are being performed Off-Pump.

The Cardiac Surgery Residents are actively involved acquiring expertise in this area.

- 10. **Trans-myocardial Laser Revascularization.** The utilization of CO2 laser was introduced to Vanderbilt in 2007. This procedure is intended for myocardial revascularization in high risk patients who are not candidates for conventional revascularization procedures: coronary bypass surgery or angioplasty and stents.
- 11. **Cerebral Oxymetry.** This technology was introduced to Vanderbilt in 2006. The purpose of its use in Cardiac Surgery is to minimize the incidence of strokes during cardiac surgery operations by monitoring the concentration of oxygen in the outer layer of the brain in the frontal area.
- 12. **Neurological Protection Strategy.** It was introduced by me to Nashville VA Medical Center to prevent strokes during cardiac surgery operations. It is similar to the one designed in Cape Cod Hospital. This strategy has two components: Cerebral Oxymetry combined with the use of intraoperative ultrasound in the ascending aorta. 2005.
- 13. **Cardiac Procurement Protocol:** This document provides a checklist and sets a prepared package to assist the assigned cardiac transplantation surgeon with the equipment necessary for the donor operation. UMass-Memorial 2001.
- 14. **Short-Term Ventricular Assist Protocol**: This protocol suggests the course of action in the management of patients in cardiogenic shock after cardiac surgery, after a myocardial infarction, acute viral myocarditis or severe ventricular arrhythmias. UMass-Memorial 2000.
